

INTERCHAIN.ME GUEST RELEASE AGREEMENT

1. Introduction

This Guest Release Agreement ("Agreement") is made between **Interchain.me**, owned and operated by **Roberto Capodieci** (the "Producer"), and the undersigned guest (the "Guest"). By signing this Agreement, Guest agrees to the following terms.

2. Grant of Rights

1. Recording Consent

Guest grants Producer the right to record, film, photograph, or otherwise capture Guest's voice, image, likeness, and statements ("Recordings") during the podcast and all related sessions or interviews for **Interchain.me** (the "Show").

2. Use and Distribution

Guest grants Producer a worldwide, perpetual, irrevocable, royalty-free license to use, copy, edit, distribute, and publicly display the Recordings, in whole or in part, in any media or format now known or later developed, for any legal purpose related to the Show (including but not limited to promotional, marketing, or archival uses).

3. Promotional Materials

Guest allows Producer to use Guest's name, likeness, biographical details, and any materials Guest provides (e.g., photographs, written content) in connection with the Show, including in promotional materials, without additional compensation or approval.

3. No Compensation

Guest acknowledges that participation is voluntary and that **no monetary or other compensation** will be provided for their appearance on the Show or for the use of the Recordings.

4. Representations and Warranties

Guest represents and warrants that:

- 1. They have full authority to enter this Agreement and to grant the rights outlined herein.
- 2. Their participation does not violate or infringe upon the rights of any third party.
- 3. They will not disclose any confidential information or violate any non-disclosure agreement during the Show.
- 4. They will provide or ensure a suitable recording environment, including stable internet, quality audio/video setup, and a quiet location.



5. Confidentiality

Guest agrees not to disclose any confidential or proprietary information regarding the Producer, the Show, or other participants. This includes, but is not limited to, any behind-the-scenes details, unreleased content, or private correspondence unless expressly authorized by Producer in writing.

6. Release and Indemnification

1. Release

Guest releases and discharges Producer, its affiliates, employees, agents, and assigns from any and all claims, demands, or causes of action arising out of or related to the Show or the use of the Recordings as allowed under this Agreement.

2. Indemnification

Guest agrees to indemnify and hold Producer harmless from any liability, loss, claims, damages, and expenses (including reasonable attorney's fees) arising from or related to (i) any breach by Guest of their representations or warranties under this Agreement, or (ii) Guest's actions during or related to the Show.

7. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of **Singapore**, without regard to its conflict of laws principles. Any disputes arising under or relating to this Agreement shall be subject to the exclusive jurisdiction of the courts of Singapore.

8. Entire Agreement

This Agreement constitutes the entire understanding between the parties concerning the subject matter herein and supersedes all prior negotiations, understandings, or agreements. No modification or amendment shall be effective unless in writing, signed by both parties.

9. Signature and Acknowledgment

By signing below, Guest acknowledges they have read, understood, and voluntarily agree to the terms and conditions of this Agreement. Guest further acknowledges they are at least eighteen (18) years of age and have the full legal capacity to enter into this Agreement.
